NOTICE IS HEREBY GIVEN Colchester Borough Council acting on behalf of the North Essex Parking Partnership in exercise of the delegated powers of the traffic authority Essex County Council granted under an Agreement dated 31 March 2011 proposes to make the above Order under Sections 1(1), 2(1) to (3), 4 (1), 4(2), 32, 35,45,46,49 and 53 and Parts III and IV of schedule 9 of the Road Traffic Regulation Act 1984

EFFECT OF THE ORDER:

1. To introduce no waiting between 8.30am – 9.30am and 2.45pm – 4.00pm Monday to Friday on the following lengths of road

Road	Description
Church Road, Rivenhall	(i) East side from a point opposite the boundary line of Number 64 and the car park access road north west for 35.5 metres (ii) East side from a point opposite the boundary line of Numbers 76 and 74 north west for 38.1 metres

2. To introduce No Stopping on School entrance markings between 8.30am – 9.30am and 2.45 – 4.00pm Monday to Friday on the following length of road

Road	Description
Church Road Rivenhall	(i) East side from a point 38.1 metres opposite the boundary line of Numbers 76 and 74 north for 84.3 metres

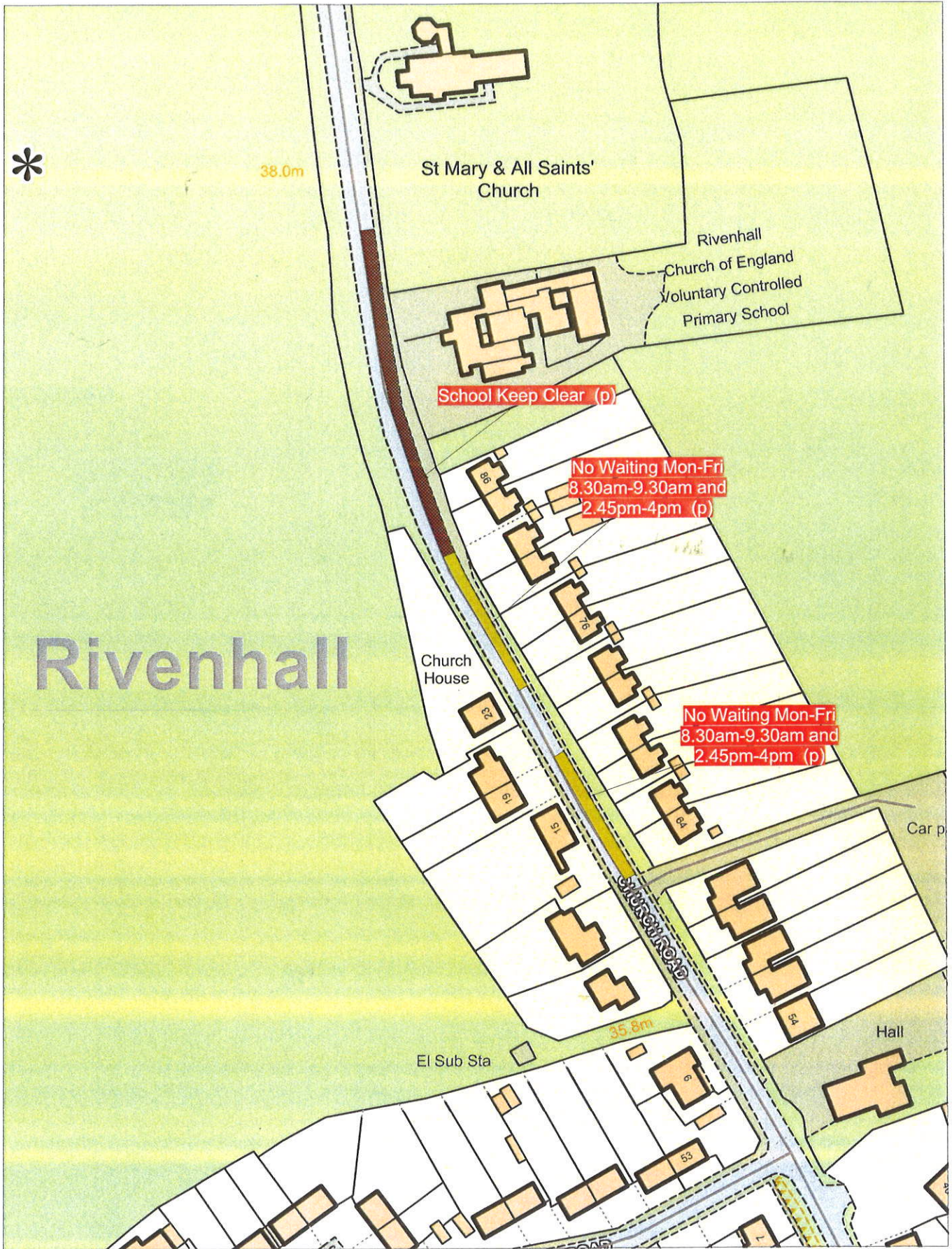
