

**The Essex County Council (Colchester Borough) (Permitted Parking and Special Parking Area) (Amendment No.18) Order 201X**

**NOTICE IS HEREBY GIVEN** Colchester Borough Council acting on behalf of the North Essex Parking Partnership in exercise of the delegated powers of the traffic authority Essex County Council granted under an Agreement dated 31 March 2011 intends to make the above Order under Sections 1(1), 2(1) to (3), 4 (1), 4(2), 32, 35,45,46,49 and 53 and Parts III and IV of schedule 9 of the Road Traffic Regulation Act 1984

**Effect of the Order**

1. To introduce No Waiting At Any time on the following lengths of road

Rotary Way- Colchester	North west side 4.0 metres north from the southern boundary wall of block 133 to 159 for a distance of 47.2 metres north east
Rectory Road- Rowhedge	North side 1.0 metre east from the west boundary wall of number 7 Rectory Road for a distance of 23.0 metres east
Taylors Road- Rowhedge	Both sides 10.0 metres north and 10.0 metres south from the junction with Colne Rise
Colne Rise- Rowhedge	Both sides 10.0 metres east and 10.0 metres west from the junction with Taylors Road
Leys Road- Wivenhoe	Both sides from a point level with the north east facing boundary wall of number 2 Leys Road for a distance of 8.0 metres south west
Saunders Drive- Colchester	South East side – from a point 14.8 metres from the junction with Lexden Road for a distance of 22.5 metres north east
Uplands Drive- Colchester	North Side – From a point opposite the boundary of numbers 26 and 28 west for a distance of 27.5 metres

This Order will be incorporated into The Essex County Council (Colchester Borough) (Permitted Parking and Special Parking Area) Order 2014 by inserting tile numbers TM025 215, TMO025 217 & TM040 230 and by substituting tile numbers TM010 265 to revision 1, TL975 250 to revision 3, TL990 257 to revision 2.
