NOTICE IS HEREBY GIVEN Colchester Borough Council acting on behalf of the North Essex Parking Partnership in exercise of the delegated powers of the traffic authority Essex County Council granted under an Agreement dated 31 March 2011 proposes to make the above Order under Sections 1(1), 2(1) to (3), 4 (1), 4(2), 32, 35,45,46,49 and 53 and Parts III and IV of schedule 9 of the Road Traffic Regulation Act 1984.

Statement of Reasons

The North Essex Parking Partnership proposes to make the above-named order following a review of the following roads in the

Skitts Hill/Brise Close

These restrictions are required to prevent commuter parking and to allow unhindered access to residential properties. The restrictions are also required to prevent danger to traffic and pedestrians and the likelihood of any such danger occurring

Chalks Road/Church Street

These restrictions are required to improve sight lines on and near the junction, to maintain the free flow of traffic and to avoid danger to persons and traffic near the junction and to allow access/egress of bus passengers at the locations

2. The Essex County Council (Braintree District) (Permitted Parking and Special Parking Area) (Consolidation) Order 2008 is hereby varied to the extent detailed in the Schedule to this order.
3. The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restrictions or requirement imposed by any regulations made or having effect as if made under the Act or by any other enactment
