

**The Essex County Council (Epping Forest District) (Permitted Parking Area and Special Parking Area)
(Amendment No.19) Order 201x**

NOTICE IS HEREBY GIVEN Colchester Borough Council acting on behalf of the North Essex Parking Partnership in exercise of the delegated powers of the traffic authority Essex County Council granted under an Agreement dated 31 March 2011 proposes to make the above Order under Sections 1(1), 2(1) to (3), 4 (1), 4(2), 32, 35,45,46,49 and 53 and Parts III and IV of schedule 9 of the Road Traffic Regulation Act 1984

EFFECT OF THE ORDER:

1. To introduce no waiting mon-sat 8am-6.30pm on the following lengths of road in the District of Epping Forest (add to schedule 8 of the 2016 Order)

Road	Description
Sun Street- Waltham Abbey	Both sides from its junction with Sewardstone Road to its junction with Darby Drive/Quaker Lane
Cleall Avenue- Waltham Abbey	North side 25.5 metres west from the junction with Rue De St Lawrence

2. To introduce resident permit holders only (Zone MS1) on the following lengths of road in the District of Epping Forest (add to schedule 43 of the 2016 Order)

Road	Description
Milton Court- Waltham Abbey	Both sides 8.9 metres west from the junction with Milton Street
Milton Street- Waltham Abbey	West side from a point level with the north facing boundary wall of number 2 Woollard Street for its entire length north East side 8.1 metres north from the junction with Woollard Street to a point 9.8 metres south from the junction with Milton Court East side 6.1 metres north from the junction with Milton Court for its entire length north All properties with a Milton Street or Milton Court (including Milton House) postal address will be able to apply for a maximum of 2 resident parking permits and unlimited visitor permits – see website for further details

3. To revoke no waiting mon-fri 1pm-2pm and replace with no waiting 2pm-3pm on the following lengths of road in the District of Epping Forest (remove from schedule 14 of the 2016 order and add new schedule 7(i) to the 2016 Order)

Stradbroke Grove- Buckhurst Hill	West side 14.8 metres north from the junction with Palmerston Road to a point 11.4 metres south from the junction with The Meadway North west side 13.4 metres north west from the junction with The Meadway for its entire length West side 29.0 metres north from the junction with Palmerston Road for its entire length
The Meadway- Buckhurst Hill	Both sides 9.8 metres west from the junction with Stradbroke Grove to a point 16.4 metres east from the junction with Roebuck Lane

4. To introduce no waiting mon-fri 8am-6pm on the following lengths of road in the District of Epping Forest (add new schedule 16(i) to the 2016 order)

Stonards Hill- Epping	North east side from the boundaries of Redgrove House/number 1 for a distance of 81.8 metres south east

5. To introduce resident permit holders only mon-fri 10am-2.30pm (Zone EF2) on the following lengths of road in the District of Epping Forest (add to schedule 52 of the 2016 order)

Ivy Chimneys Road-Epping	South side from the east facing boundary of number 66 for a distance of 78.5 metres west Even numbers 36-66 Ivy Chimneys Road will be able to apply for one resident permit and unlimited visitor permits. – see website for further details.

Oakwood Hill Industrial Estate-Loughton	South east side 58.7 metres south west from the north east facing boundary wall of number 43 for a distance of 18.5 metres south west South east side 92.5 metres south west from the north east facing boundary wall of number 43 for a distance of 17.5 metres south west North west side 15.5 metres south west from the south west facing boundary wall of number 18 for a distance of 18.0 metres south west North west side 44.5 metres north east from the north east facing boundary wall of number 17 for a distance of 17.3 metres north east
Tidys Lane-Epping	South west side 13.2 metres south east from the junction with Palmers Hill for a distance of 95.4 metres south east
Algers Road-Loughton	South west side 10.0 metres north west from the junction with Algers Mead south east to a point level with the south east facing boundary wall of numbers 12/14 Algers Road Both sides 10.0 metres west from the junction with Lower Park Road South west side 10.0 metres north west from the junction with The Avenue south east to a point 9.0 metres east of the same junction
Lower Park Road-Loughton	West side 10.0 metres south from the junction with Algers Road to a point 9.8 metres north of the same junction
The Avenue-Loughton	Both sides 10.5 metres south west from the junction with Algers Road

Algers Mead-Loughton	Both sides 8.0 metres south west from the junction with Algers Road
Algers Close-Loughton	Both sides from the junction with Algers Road south west to a point level with the north east facing boundary wall of numbers 11/13 Algers Road
Albion Hill-Loughton	Both sides from the junction with Nursery Road for a distance of 10.0 metres south east South east side 9.6 metres north west from the junction with Pollards Close to a point 9.3 metres south east of the same junction North east side 10.0 metres north west from the junction with Albion Park to a point 10.0 metres south east of the same junction North west side from a point level with the north west facing boundary wall of number 19 for a distance of 54.0 metres south east
Nursery Road-Loughton	South east side 10.0 metres south west from the junction with Albion Hill to a point 10.0 metres north west from the same junction
Albion Park-Loughton	Both sides from the junction with Albion Hill for a distance of 10.0 metres north
Pollards Close-Loughton	Both sides from the junction with Albion Hill for a distance of 10.0 metres south west
Green Glade-Theydon Bois	South west side 10.9 metres south east from the junction with Poplar Row for a distance of 48.6 metres south east

7. To introduce resident permit holders only mon-fri 10am-4pm (Zone L7) on the following length of road in the District of Epping Forest (add to schedule 44 of the 2016 order)

Algers Mead-Loughton	Both sides south west for the entire length 8.0 metres south west from the junction with Algers Road
Algers Close-Loughton	Both sides south west for the entire length from a point level with the north east facing boundary wall of numbers 11/13 Algers Road
Algers Road-Loughton	North east side 15.3 metres south east from the junction with High Road to a point 10.0 metres west from the junction with Lower Park Road South side 10.0 metres west from the junction with Lower Park Road to a point 9.0 metres east from the junction with The Avenue South west side 10.0 metres north west from the junction with The Avenue to a point level with the south east facing boundary wall of numbers 12/14 Algers Road South west side 15.3 metres south east from the junction with High Road to a point 10.0 metres north west from the junction with Algers Mead All properties in Algers Mead/Algers Close & numbers 1-76 Algers Road inclusive will be able to purchase 2 parking permits and unlimited visitor permits – see website for further details

8. To revoke no waiting mon-fri 2pm-3pm on the following lengths of road in the District of Epping Forest (remove from schedule 7 of the 2016 order)

Algers Road-Loughton	North east side 15.3 metres south east from the junction with High Road to a point level with the boundary of numbers 12/14 & 26 Algers Road

Algers Road-Loughton	South west side from the junction with Algers Close to the junction with Lower Park Road North east side from the junction with Lower Park Road to a point level with the north west facing boundary of number 68 Algers Road
Lower Park Road-Loughton	West side 10.0 metres south from the junction with Algers Road to a point 9.8 metres north of the same junction
The Avenue-Loughton	Both sides 10.5 metres south west from the junction with Algers Road

9. To introduce no stopping mon-fri 8.00-9.30am & 2.30-4.30pm on school entrance markings on the following lengths of road in the District of Epping Forest (add to schedule 58 of the 2016 order)

High Road-Buckhurst Hill	South east side from a point level with the south west facing boundary wall of number 51 St Johns Terrace for a distance of 30.5 metres south west South east side 45.5 metres south west from the south west facing boundary wall of number 51 St Johns Terrace for a distance of 15.5 metres south west

10. To revoke no waiting at any time restrictions and replace with resident permit holders only (Zone M) markings on the following lengths of road in the District of Epping Forest (remove from schedule 1 of the 2016 order and add to schedule 43 of the 2016 order)

Road	Description
Market Place-Abridge	North west side 7.5 metres south east from the south east facing boundary wall of The New Roding to a point 1.5 metres south west from the same boundary wall to a point 22.0 metres north east towards the junction with Abridge Road Numbers 1-4 Goulds Cottages-Abridge will be able to purchase 2 resident parking permits and unlimited visitor permits – see website for further details

11. To revoke no stopping mon-fri 8.00-9.30am & 2.30-4.30pm on school entrance markings and replace with no stopping mon-fri 8am-4pm on school entrance markings on the following lengths of road in the District of Epping Forest (remove from schedule 58 of the 2016 order and add new schedule 58(i) to the 2016 order)

Road	Description
Albion Hill-Loughton	South west side 13.0 metres south east from the north west facing boundary wall of number 10 for a distance of 51.5 metres south east

12. To introduce no waiting mon-fri 8am-9.30am & 2.30-4.30pm restrictions on the following lengths of road in the District of Epping Forest (add to schedule 69 of the 2016 order)

Road	Description
Albion Hill-Loughton	South east side from a point level with the south facing corner of number 5.5 Albion Hill to a point level with the north west facing boundary wall of number 4 Albion Hill South east side from a point level with the boundary of numbers 8/10 Albion Hill to a point 9.3 metres south east from the junction with Pollards Close South east side 9.6 metres north west from the junction with Pollards Close to a point 10.0 metres south east from Nursery Road

13. To revoke Permit Holders Only Mon-Fri 10am-4pm (Zone TB1) on the following lengths of road in the District of Epping Forest (remove from schedule 44 of the 2016 Order)

Road	Description
Green Glade-Theydon Bois	North east side 10.9 metres south east from the junction with Poplar Row for a distance of 49.1 metres south east South west side 10.9 metres south east from the junction with Poplar Row for a distance of 48.6 metres south east

14. To introduce limited waiting 1 hour no return within 3 hours on the following length of road in the District of Epping Forest (add new schedule 29(i) to the 2016 Order)

Road	Description
Green Glade-Theydon Bois	North east side 10.9 metres south east from the junction with Poplar Row for a distance of 49.1 metres south east

15. To revoke Limited Waiting Mon-Sat 8am-7pm 1 Hour No Return 3 Hours and replace with Pay & Display Mon-Fri 7am-6pm (excluding bank & public holidays) on the following lengths of road in the District of Epping Forest (remove from schedule 32 of the 2016 order and add new schedule 53(i) to the 2016 order)

Road	Description
Loughton Lane-Theydon Bois	South east side 11.7 metres north east of the junction with The Green for a distance of 15.3 metres north east South east side 45.8 metres north east of the junction with The Green for a distance of 31.2 metres north east South east side 77.3 metres north east of the junction with The Green for a distance of 31.0 metres north east.
