

The Essex County Council (Epping Forest District) (Permitted Parking Area and Special Parking Area) (Amendment No.8) Order 201x

NOTICE IS HEREBY GIVEN Colchester Borough Council acting on behalf of the North Essex Parking Partnership in exercise of the delegated powers of the traffic authority Essex County Council granted under an Agreement dated 31 March 2011 proposes to make the above Order under Sections 1(1), 2(1) to (3), 4 (1), 4(2), 32, 35,45,46,49 and 53 and Parts III and IV of schedule 9 of the Road Traffic Regulation Act 1984

EFFECT OF THE ORDER:

1. To introduce Permit Holders Only Mon-Fri 10am-4pm (Zone TB1) on the following lengths of road in the District of Epping Forest (add to schedule 44 of the 2016 Order)

Green Glade-Theydon Bois	<p>North east side 10.9 metres south east from the junction with Poplar Row for its entire length to a point level with the east facing boundary of number 61 Green Glade</p> <p>South west side 10.9 metres south east from the junction with Poplar Row to a point 10.0 metres north west from the junction with Pakes Way</p> <p>South west side 10.0 metres south east from the junction with Pakes Way to a point level with the south facing boundary wall of number 31 Green Glade.</p> <p>West side 12.0 metres south from north facing boundary wall of number 36 Pakes Way to a point level with the boundaries on numbers 56/58 Green Glade</p> <p>South west side from a point level with the boundaries of numbers 56/58 Green Glade to a point level with the east facing boundary wall of number 61 Green Glade</p>
Pakes Way-Theydon Bois	<p>Both sides from a point 10.0 metres south west from the junction with Green Glade (north exit) to a point 9.0 metres west from the junction with Green Glade (east exit)</p> <p>All properties with a Green Glade or Pakes Way postal address will be able to apply for a maximum of 2 parking permits and unlimited visitor permits</p>

Hornbeam Road-Theydon Bois	<p>Both sides from the south east facing boundary wall of number 6 Graylands to a point level with the north east facing boundary wall of number 41 Hornbeam Road</p> <p>South west side from the boundary of 37/39 Hornbeam Road to the boundaries of 1 Hornbeam Close/13 Hornbeam Road</p> <p>North east side from the north west facing boundary wall of number 39 Hornbeam Road to a point level with the north west facing boundary wall of number 35 Hornbeam Road</p> <p>South west side from the boundary of numbers 41/43 Hornbeam Road to a point level with the south west facing boundary wall of number 32 Hornbeam Road</p> <p>North east side from the northern boundary of number 10 Hornbeam Road to a point level with the boundaries of numbers 46/48 Hornbeam Road</p> <p>North east side from the boundary of numbers 46/48 Hornbeam Road, to run north west, then south east, then south west to a point 12.2 metres south east from the junction with Loughton Lane</p>

Hornbeam Close- Theydon Bois	North side from the boundaries of number 2/4 Hornbeam Road for a distance of 11.5 metres west
	South west side 11.5 metres from the junction with Loughton Lane for a distance of 17.5 metres south east
	South east side from the south west facing boundary of number 1 Hornbeam Close for its entire length in a general direction north east
Woburn Avenue- Theydon Bois	North west side from a point opposite the boundaries of numbers 1 & 2 Hornbeam Close for its entire length in a general direction north east
	Both sides from a point level with the south east facing boundary wall of number 2 Hornbeam Road to a point level with the south east facing wall of number 14 The Green
The Green- Theydon Bois	South east side from a point level with the south east facing boundary wall of number 1 Chestnut Cottage to the junction with Woburn Avenue
	North east side from a point level with the south east facing boundary wall of number 1 Chestnut Cottages to a point level with the east facing boundary wall of number 7 The Green
	North east side from a point level with the north west facing boundary wall of number 14 The Green for a distance of 50.0 metres south east
The Green-(Green View-Theydon Bois	Both sides from the junction with Woburn Avenue for its entire length
	All properties with a Hornbeam Road, Hornbeam Close, Woburn Avenue or The Green (includes Chestnut Cottages/Green View) postal address will be able to apply for a maximum of 2 parking permits and unlimited visitor permits

3. To introduce Permit Holders Only (Zone 1) on the following lengths of road in the District of Epping Forest (add to schedule 43 to the 2016 order)

Road	Description
Bansons Way- Ongar	Both sides 11.6 metres from the junction with the A128 to a point level with the west facing boundary wall of number 16 Bansons Way
	The residents of the following properties may apply for a maximum of 2 permits per property & unlimited visitor permits: Numbers 1-16 Bansons Way inclusive (includes Station Court 1-5)

4. To introduce Permit Holders Only (Zone BH1) on the following length of road in the District of Epping Forest (add to schedule 43 to the 2016 Order)

Road	Description
High Road- Buckhurst Hill	North west side 12.0 metres north east from the junction with Beech Lane for a distance of approximately 42.0 metres north east
	The residents of the following properties may apply for a maximum of 1 permit per property & unlimited visitor permits: Numbers 2-14 High Road, Buckhurst Hill inclusive.

5. To revoke No Waiting At Any time and replace with Permit Holders Only (Zone BH2) on the following length of road in the District of Epping Forest (remove from schedule 1 of the 2016 order and add to schedule 43 of the 2016 Order)

Road	Description
Albert Road- Buckhurst Hill	East side 3.0 metres from a point level with the northern kerb line of Elgar Close for a distance of 33.5 metres The residents of the following properties may apply for a maximum of 1 permit per property & unlimited visitor permits: Numbers 12-24 Albert Road, Buckhurst Hill inclusive.

6. To revoke No Waiting Mon-Fri 10am-11am on the following lengths of road in the District of Epping Forest (remove from schedule 4 of the 2016 order)

Road	Description
Green Glade- Theydon Bois	Both sides from the junction with Poplar Row for a distance of approximately 60.0 metres in a south easterly direction

7. To revoke No Waiting Mon-Fri 11am-Midday on the following length of road in the District of Epping Forest and replace with No Waiting At Any time (remove from schedule 2 of the 2016 order and add to schedule 1 of the 2016 order)

Road	Description
Poplar Row- Theydon Bois	From a point 12.5 metres north east of the junction with Green Glade to a point 12.4 metres south west of the same junction

8. To revoke No Waiting Mon-Sat 8am-6pm and replace with No Waiting At Any time on the following lengths of road in the District of Epping Forest (remove from schedule 3 of the 2016 order and add to schedule 1 of the 2016 Order)

Road	Description
Bansons Way- Ongar	Both sides from the junction with the A128 for a distance of 11.6 metres west
A128-Ongar	14.7 metres north from the junction with Bansons Way to a point 14.0 metres south from the same junction

9. To introduce No Waiting At Any time on the following lengths of road in the District of Epping Forest (add to schedule 1 of the 2016 Order)

A104-Buckhurst Hill (Boleyn Court)	West side from a point level with the south facing boundary wall of numbers 15-28 Boleyn Court for a distance of approximately 38.2 metres south
Station Road-Sawbridgeworth	North side from the Essex/Herts boundary for a distance of approximately 162.0 metres east South side from the Essex/Herts boundary for a distance of approximately 196.0 metres east
Station Road-Loughton (Sainsburys side-access road)	North west side from the Alderton Hill roundabout for a distance of approximately 61.3 metres south east Left central road island/crossing point, north east side from the junction with the Alderton Hill roundabout to a point level with the same junction to run along the north west side of same island Central island north east side, 12.0 metres south east from the Alderton Hill roundabout for a distance of 84.4 metres south east South west side approximately 82.8 metres south east from the Alderton Hill roundabout for a distance of 16.0 metres south east

Hornbeam Road-Theydon Bois	Both sides from the junction with Graylands east for a distance of 13.8 metres Both sides 11.5 metres north east from the north east facing boundary wall of number 39 Hornbeam Road North west side from the boundary of numbers 41/43 Hornbeam Road to a point level with the boundaries of 37/39 Hornbeam Road North east side level with the south east facing boundary wall of number 41 Hornbeam Road south east for a distance of 28.0 metres North east side level with the north west facing boundary wall of number 35 Hornbeam Road south east then east for a distance of 35.0 metres North west side 11.2 metres south west from the junction with Woburn Avenue
Hornbeam Road/Hornbeam Close-Theydon Bois	North west side from the junction with Woburn Avenue to a point level with the boundaries of 1 & 2 Hornbeam Close

Hornbeam Road- Theydon Bois	North east side from the junction with Loughton Lane south east for a distance of 12.2 metres South west side from the junction with Loughton Lane south east for a distance of 11.5 metres North west side from a point level with the south west facing boundary wall of number 32 Hornbeam Road north east for a distance of 25.5 metres
Loughton Lane- Theydon Bois	South east side from a point level with the boundaries of numbers 1 & 2 Maple Close to a point 11.3 metres north east from the junction with Hornbeam Road
Woburn Avenue- Theydon Bois	South west side 11.4 metres north west from the junction with Hornbeam Road North east side 10.6 metres north west from the junction with Hornbeam Road
The Green- Theydon Bois	South west side from the entrance to Dossetts Retreat for a distance of 20.5 metres south east

10. To revoke No Waiting Mon-Fri 8am-6pm on the following lengths of road in the District of Epping Forest

Road	Description
Castle Street- Ongar	North side from its junction with the High Street east for approximately 43.0 metres South side from its junction with the High Street east for approximately 91.0 metres

The Essex County Council (Epping Forest District) (Permitted Parking Area & Special Parking Area) (Consolidation) Order 2016 will be varied by the above Order.
