

**The Essex County Council (Braintree District) (Permitted Parking Area and Special Parking Area) (Amendment No.50) Order 20\*\***

**NOTICE IS HEREBY GIVEN** Colchester Borough Council acting on behalf of the North Essex Parking Partnership in exercise of the delegated powers of the traffic authority Essex County Council granted under an Agreement dated 31 March 2011 proposes to make the above Order under Sections 1(1), 2(1) to (3), 4 (1), 4(2), 32, 35,45,46,49 and 53 and Parts III and IV of schedule 9 of the Road Traffic Regulation Act 1984.

**Effect of the Order**

1. To revoke 24 Clearway (no stopping at any time) restriction on the following length of Guithavon Street in the Parish of Witham in the District of Braintree

Road	Description
Guithavon Street, Witham	Both sides:- from a point 36.5 metres north west of its junction with Newland Street to a point 15 metres north west of its junction with Newlands Drive

2. To revoke no waiting at any time restrictions on the following length of Guithavon Street in the Parish of Witham in the District of Braintree.

Road	Description
Guithavon Street, Witham	(i) South side, from its junction with Newland Street, north-west for a distance of approximately 8.5 metres. (ii) North side, from its junction with Newland Street, north-west for a distance of approximately 36.5 metres

3. To introduce no waiting and no loading at any time on the following lengths of Guithavon Street in the Parish of Witham in the District of Braintree

Road	Description
Guithavon Street, Witham	(i) North side, from its junction with Newlands Street, northwest to a point 15 metres northwest of its junction with Newlands Drive. (ii) South side, from its junction with Newlands Street north west for approximately 8.5 metres (iii) South side, from a point 36.5 metres north west of its junction with Newlands Street, north west to a point 15 metres northwest of its junction with Newlands Drive

This Order will be incorporated into The Essex County Council (Braintree District) (Permitted Parking Area and Special Parking Area) (Consolidation) Order 2008 by substituting tile numbers TL815 145 revision 2 with revision 3, TL820 145 revision 3 with revision 4, and TL820 142 revision 3 with revision 4.
