

The Essex County Council (Colchester Borough) (Waiting Restriction)
(Consolidation) (Amendment No 41) Order 2012

NOTICE IS HEREBY GIVEN Colchester Borough Council acting on behalf of the North Essex Parking Partnership in exercise of the delegated powers of the traffic authority Essex County Council granted under an Agreement dated 31 March 2011 proposes to make the above Order under Sections 1(1), 2(1) to (3), 4 (1), 4(2), 32, 35,45,46,49 and 53 and Parts III and IV of schedule 9 of the Road Traffic Regulation Act 1984.

EFFECTS OF THE ORDER: To introduce traffic regulation orders to restrict stopping and waiting in those lengths of road described below. These restrictions are required in the interests of public safety.

To Introduce No Stopping Mon – Fri 8.30am - 9.30am and 3pm – 4pm on school entrance markings

Villa Road, Colchester

- (i) West side from a point 42.5 metres north of the northern boundary on no.25 Villa Road north for a distance of 74.6 metres

To Introduce No Waiting at time

Villa Road, Colchester

- (i) East Side from a point 35 metres north of the northern boundary line of No.25 north for a distance of 7.5 metres

Coventry Close

The South Side from a point 14 metres west from its junction with Lincoln Way west for a distance of 35 metres and then north for a distance of 7 metres.

Eudo Road

- (i) South West Side for its entire length
- (ii) South East Side from its junction with Shrub End Road east for a distance of 12 metres
- (iii) South East Side from a point 25.5 metres from its junction with Shrub End Road east for a distance of 102.5 metres

Victoria Esplanade, West Mersea

- (i) North Side from a point 2 metres east of the western boundary of number 33 south east for a distance of 35 metres
- (ii) South Side from a point 8 metres east of the western boundary of number 33 south east for a distance of 29 metres.

High Street, Dedham

- (i) South Side from a point opposite the eastern boundary of Royal Square for a distance of 23 metres in a western direction

To introduce limited waiting 90 minutes no return within 4 hours

Eudo Road

- (i) South East Side from a point 12 metres from its junction with Shrub End Road, in a south easterly direction for a distance of 13.5 metres
