

The Essex County Council (Colchester Borough) (Waiting Restriction)
(Consolidation)(Amendment No 41) Order 20**

WHEREAS Colchester Borough Council acting on behalf of the North Essex Parking Partnership in exercise of the delegated powers of the traffic authority Essex County Council granted under an Agreement dated 31 March 2011 hereby makes the above Order under sections 1(1), 2(1) to (3), 4 (1), 4(2), 32,45,46,49 and 53 and Parts III and IV of Schedule 9 of the Road Traffic Regulation Act 1984.

1. This Order may be cited as the Essex County Council (Colchester Borough) (Waiting Restriction) (Consolidation) (Amendment No 41) Order 20** and shall come into operation on*****

2. The Essex County Council (Colchester Borough) (Waiting Restriction) (Consolidation) (Amendment No 41) Order 20**

3. The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restrictions or requirement imposed by any regulations made or having effect as if made under the Act or by any other enactment.

The Essex County Council (Colchester Borough) (Waiting Restriction) (Consolidation) Order 2008 is varied as follows

Insert new Article:-6Lvii Wait at any time on any day in the lengths of roads specified in schedule 50A for a period longer than 90 minutes or, if a period of less than 4 hours has elapsed since the previous period of waiting by the same vehicle in the same length of road

List of Schedules

Add the following Schedules

50A – Limited waiting 90 minutes no return within 4 hours

No waiting at any time restrictions to be introduced (existing restrictions contained within schedule 63 of the 2008 order)

Villa Road, Colchester

East side from a point 35 metres north of the northern boundary line of No 25 north for a distance of 7.5 metres

Coventry Close, Colchester

The South Side from a point 14 metres west of its junction with Lincoln Way west for a distance of 35 metres and then north for a distance of 7 metres

Eudo Road, Colchester

South West side for its entire length

South East Side from its junction with Shrub End Road east for a distance of 12 metres

South East side from a point 25.5 metres from its junction with Shrub End Road east for a distance of 102.5 metres

Victoria Esplanade, West Mersea

North Side from a point 2 metres east of the western boundary of No 33 south east for a distance of 35 metres

South Side from a point 8 metres east of the western boundary of No 33 south east for a 29 metres

High Street Dedham

South side from a point opposite the eastern boundary of Royal Square for a distance of 29 metres in a western direction

No Stopping Mon-Fri 8am – 9.30am and 3pm- 4 pm (existing restrictions contained within schedule 62G of the 2008 Order)

Villa Road, Colchester

West side from a point 42.5 metres north of the northern boundary of No 25 north for a distance of 74.6 metres

Introduce limited waiting 90 minutes on return within 4 hours

Eudo Road

South East Side from a point 12 metres from its junction with Shrub End Road, in a south easterly direction for a distance of 13.5 metres
