

The Essex County Council (Uttlesford District) (Permitted Parking Area and Special Parking Area) (Amendment No.63) Order 201*

NOTICE IS HEREBY GIVEN Colchester Borough Council acting on behalf of the North Essex Parking Partnership in exercise of the delegated powers of the traffic authority Essex County Council granted under an Agreement dated 31 March 2011 proposes to make the above Order under Sections 1(1), 2(1) to (3), 4 (1), 4(2), 32, 35,45,46,49 and 53 and Parts III and IV of schedule 9 of the Road Traffic Regulation Act 1984.

Effect of the Order

1. To introduce a clearway restriction (No Stopping At Any time) and include no stopping on verge or footway on the following lengths of road in the District of Uttlesford

Road	Description
Molehill Green-Takeley	Both sides 22.5 metres north east from the junction with Waltham Hall Road
Elsenham Road/Waltham Hall Road-Takeley	Both sides 10.5 metres south east from the entrance to Loppingdales Farm House for a distance of approximately 0.9 miles south east
Bambers Green Road/Waltham Hall Road-Takeley	Both sides 2.5 metres south east from the from the rear boundary of number 6 Bury Villas for a distance of approximately 0.9 miles north west
Smiths Green Lane-Takeley	Both sides 43.3 metres from the south west facing boundary wall of number 1 Easton View for a distance of approximately 0.8 miles south

This Order will be incorporated into The Essex County Council (Uttlesford District) (Permitted Parking Area and Special Parking Area) (Consolidation) Order 2008 by substituting the following tile numbers, TL560 237 with revision 1, TL560 240 with revision 1, TL560 242 with revision 1, and inserting new tile numbers TL555 247, TL555 250, TL555 252, TL560 245, TL560 247, TL565 217, TL565 220, TL565 222, TL565 225, TL565 235, TL565 237, TL565 240, TL570 225, TL570 227, TL570 230, TL570 232, TL570 235, TL570 237, TL575 227, TL575 230, TL575 232 and TL575 235.
