

The Essex County Council (Uttlesford District) (Permitted Parking Area and Special Parking Area) (Amendment No.67) Order 201*

NOTICE IS HEREBY GIVEN Colchester Borough Council acting on behalf of the North Essex Parking Partnership in exercise of the delegated powers of the traffic authority Essex County Council granted under an Agreement dated 31 March 2011 proposes to make the above Order under Sections 1(1), 2(1) to (3), 4 (1), 4(2), 32, 35,45,46,49 and 53 and Parts III and IV of schedule 9 of the Road Traffic Regulation Act 1984.

Effect of the Order

1. To introduce no waiting at any time restrictions on the following lengths of road in the District of Uttlesford

Road	Description
Beehive Court-Hatfield Heath	West side 3.0 metres north from the junction with the A1060 service road for a distance of 17.5 metres north

2. To revoke limited waiting mon-sat 8am-6pm 30 mins no return 3 hours on the following lengths of road in the District of Uttlesford

Road	Description
Common Hill-Saffron Walden	East side from a point 39.0 metres south from the junction with Ashdon Road for a distance of 28.5 metres south
Ashdon Road-Saffron Walden	South side from a point 22.0 metres from the junction with Common Hill for a distance of 16.5 metres east

3. To introduce resident permit holders only (Zone HH1) & limited waiting 8am-5pm 1 hour no return within 2 hours on the following lengths of road in the District of Uttlesford

Road	Description
Beehive Court-Hatfield Heath	East side 3.0 metres north from the junction with the A1060 service road for a distance of 11.5 metres north The following properties all with The Heath, Hatfield Heath addresses will be able to purchase one parking permit each and unlimited visitor permits. Elsmore, Flats 1 & 2 High View, Primley, Raj of India, Shanghai Cottage, Gynesta Cottage, Jays Cottage, The Flower Pot, Beehive Cottage, No 1 & No 2 Hockley Cottages.
